OTC COLA June 2017 Member Meeting Time & Location Change




Nextdoor is a free app that connects neighbors for a wide range of useful and helpful reasons. The app is becoming extremely popular across the country. It is distinct from apps like Facebook in that it is not meant to share recipes, political opinions, quotes, etc. The purpose of Nextdoor is to share needed, desired and otherwise useful information. It is neighborhood specific (you have to verify your lake address to join). Local sub neighborhoods ("Groups" can be set up just for your beach) can be set up What can you do with Nextdoor?

- Report lost items or pets
- Broadcast notice of dangerous weather on the lake
- Send an emergency alert to you neighbors for help
- Stranded on the lake? see who of your neighbors can give assistance
- Share information on road construction
- Ask for recommendations for plumbers, carpenters, baby sitters, etc.
- Sell or give away household items
- Invite neighbors to beach get-togethers
- Exchange information about crime and safety issues
- Nind neighbors in the Nextdoor Directory
- View a neighborhood map.
- Ask for advice
- Get the idea?

Sophia's Law - Carbon Monoxide Law for Boaters What you need to know and how to comply.

UPDATE:

The effective date for Sophia's Law has been delayed to May 1, 2018.

What is required for my boat?

Sophia's Law is named for seven-year-old Sophia Baechler, who died from carbon monoxide poisoning while boating on Lake Minnetonka. Carbon monoxide (CO) is an odorless, colorless, tasteless gas that can be toxic even in very small quantities since its effects are cumulative over time. Whether inside, outside, underway or anchored, passengers of many types of boats with a motor can quickly become victims of CO poisoning. A quick inspection every time you operate your boat can save a life, carbon monoxide poisonings are preventable.

Lakes With Zebra Mussels Are Goners

It's time for us to stop (stop!) letting invasive species hitch a ride to our docks.

New invasive species continue to arrive in Wisconsin and Minnesota largely from the Great Lakes - on a weekly basis. Altogether, 180 invasive aquatic species are identified in the Great Lakes, according to the National Oceanic and Atmospheric Administration - allowed in by our government during our lifetimes.

For economic reasons, our elected officials encouraged international freighters to enter our fresh waters from the Atlantic via the St. Lawrence Seaway and sail all the way to Wisconsin and Minnesota. Did you know that Congress has allowed most all the ports of the world to send vessels right into Green Bay or Duluth with one or two stops? And we allowed them to empty their dangerous ballast tanks into American freshwater lakes - introducing a few hundred alien species from who-knows-where.

Over the past 30 years a nasty critter called the zebra mussel has hitchhiked and stowed away to cross lakes, rivers and streams - all the way to Wisconsin and Minnesota. Then they hitched rides at 60 miles per hour on highways, to reach hundreds of lakes, attached to boats and trailers - all the way to California. **MORE**



Minnesota to Accelerate the Pace of Progress Towards Clean Water

That is why Governor Dayton recently announced a new <u>"25 by '25" Water</u> Quality Goal, which would spur collaboration and action to improve Minnesota's water quality 25 percent by 2025. Without additional action, the quality of Minnesota's waters is expected to improve only 6 to 8 percent by 2034. Governor Dayton wants to hear from Minnesotans and will host a series of <u>Town Halls</u> over the summer and fall. In addition, he is calling on Minnesotans and civic organizations to organize their own Community Water Meetings this summer to provide further feedback and ideas.

Gather your community, school, family and friends to have a conversation this summer about what you can do at the local level to help Minnesota reach our 25 by 25 goal!

Community Water Meetings will take place June – August. Hosts will be provided with a conversation guide, information on water quality in your local region and <u>MORE.</u>



I have been a DNR groundwater hydrologist in Fergus Falls for seven years after transferring from the same position in St. Paul. Since our surface and groundwater resources belong to all of the people of the State of Minnesota it is our duty to protect the quantity and sustainability of our water resources. As a DNR groundwater hydrologist, my job is regulatory – permitting the use of large quantities of groundwater. The other groundwater hydrologists throughout the state and myself ensure the quantity of groundwater is not depleted and shared among all citizens, with domestic water use being top priority. **MORE**

A public Information Meeting will be held June 15th at the Pelican Rapids School Auditorium from 7:00 pm to 9:00 pm. The Public Information Meeting will provide the public an opportunity to participate in the public comment period with public testimony and an opportunity to gather information regarding the proposed Star Lake Casino Development project . A decision about the need for a more detailed analysis of the potential impacts of the project through the completion of an Environmental Impact Statement will be made by the Otter Tail County Board following the close of the public comment period.
