# **From the President**

The Otter Tail County Coalition of Lake Associations will meet for the first time this season on Thursday, May 17, at 7:00 p.m. OTC COLA meets on the third Thursday of the month from May through August at the Community Center in the City of OtterTail. on September 20 a Day Trip is planned with the East Otter Tail Soil and Water District to highlight shore land conservation projects. COLA is a volunteer group that partners with Lake Associations to sponsor water quality testing programs, communications, education and legislative forums in Otter Tail County.

"Call 911. Then what?" Is the topic of the evening. Coffee and cookies and a brief business meeting will precede an informative discussion and question and answer session on the 911 system in Otter Tail County. How do dispatchers send you emergency assistance for a fire or for a medical emergency? Who are the First Responders around the lake? Can they find you from your cell phone? Fergus Falls Fire Chief Ryan Muchow will lead a panel of emergency personnel. He was hired and returned to Fergus Falls in 2017 after experience as a Moorhead firefighter. Trevor Reeves, Pelican Rapids Fire Chief and President of the OTC Fire Chief's Association will be on the panel. Perham Mayor and firefighter Tim Meehl will participate from his perspective.

Sheriff's Deputy Jim Iverson will speak for Law Enforcement. He works with the Otter Tail County Aquatic invasive Task Force for the summer months enforcing all things water related including Clean, Drain and Dry. Deputy Iverson will display the new Lund boat purchased by the County's AIS Task Force in 2017 for his use. The boat is fully equipped and features the logo for the Task Force, replacing an out of date boat from the Sheriff's Department. OTC Deputy Barry Fitzgibbons will be available to answer questions about 911.

The Board of the OTC Coalition of Lake Associations encourages all lakeshore property owners to share an evening of information, fellowship, refreshments and door prizes on May 17.

The question for the COLA meeting on June 21 will be "Why are we testing the waters?." Moriya Rufer of RMB Laboratories will analyze test results and offer suggestions for dealing with results on individual lakes that are in the COLA testing program.

## Water Testing Program Kickoff

On Thursday evening April 19 Ellie Kriese and Moriya Rufer from RMB Environmental Laboratories, Detroit Lakes, along with Russ Severson from OTC COLA, began the kickoff of the 2018 lake water sampling season. The water sampling volunteers started to arrive at 5:00pm at the community center in Ottertail. By 6:00pm the crew had distributed kits to thirty-five lake testing volunteers.

The 2018 water samples are taken on the third Monday of each month during the summer: May 21, June 18, July 16, August 20 and September 17. The samples are then taken to a designated drop off locations or delivered to RMB Environmental Laboratories for analysis and recording the data.

This lakes monitoring program involves the collection of total phosphorus and chlorophyll-a samples. Other observations such as Secchi disk, lake level, rainfall, and recreational suitability are also documented. Citizen volunteers collect water samples once a month from May through September and submit them to the lab. Data results are posted to the <u>RMB website</u> and analysis is distributed by OTC COLA .

# Update On Ramp And Dock Spring Readiness

The late ice out compressed our normal repair season of 6-7 weeks into a three week rush.

Our crew has been busy working 10-11 hour days 6 days a week for the past two weeks. Douglas County ice lasted a bit longer so we were more focused on Otter Tail County. This week we are in Douglas County

All the ramps in Otter Tail County should be usable now. Please take a really good look at the ramps every time before you launch . There can be damage that is difficult to see on windy days. Power loading can pull planks apart and create gaps and a blow hole at the end that can damage your trailer if you get hung up in them.

There are a few floating docks at Rush north, Big Pine, Leaf lakes that may not get put in until next week. Floating docks require our backhoe to lift them into the water and our backhoe has been busy fixing ramps. All roll in Docks in Otter Tail county were in by late in the day on Saturday May 5<sup>th</sup>

We will have all of our 160 roll in docks in the water by this week end.

Clean, Drain, and Dry all your boats and equipment every time it goes in and out of a lake. Water must be swapped out with clean non lake water to transport bait as you leave the access. It is illegal to transport lake water. Do your part to protect all our lakes from invasive species.

Stay Safe. Invest in a good comfortable life jacket and wear it. Water temperatures are pretty cold. We have had a couple of tragic losses the past few years that are preventable. Wear it for all the people who love you so that you can love them back.

## DNR Advises People To Keep Aquarium Pets And Plants Out Of Minnesota Waters

To help protect Minnesota waters, the Department of Natural Resources is reminding people to properly dispose of prohibited or unwanted aquarium plants and animals.

"It's important for hobbyists, teachers, parents and children to know that they should never release aquarium animals or plants into the wild," said Heidi Wolf, DNR invasive species unit supervisor. "Some of the pets and plants that live in aquariums are prohibited species that can cause serious harm if released into lakes, rivers or ponds."

# **OTC Will Have 24 Watercraft Inspectors**

County Land and Resources Director Bill Kalar told county commissioners on March 27 that 24 watercraft inspectors have been hired to work at county lake accesses during the summer of 2018.

The 24 summer workers will work directly with Spencer McGrew, Otter Tail County's Aquatic Invasive Species task force specialist. Before leaving a lake, fishermen are required to drain water from boats, motors and livewells. Boat owners also are urged to perform water draining away from boat ramps **MORE**
