Moriya Rufer To Speak At OTC COLA June Meeting

The featured speaker at the June 21, 2018 OTC COLA General Meeting at 7:00 pm, at the Ottertail Community Center in Ottertail, MN is Moriya Rufer of RMB Laboratories. RMB Laboratories partners with OTC COLA for annual water quality testing of over 100 lakes in Otter Tail County.

Otter Tail COLA lakes have collected water quality data for many years but sometimes are unsure of how to access it or use it for better lake management. This presentation will provide lake residents with useful information on how to find and best use their lake data. Participants will be provided a one-page summary of their past lake data, and then we will work through a lake diagnostic worksheet to take home with them that will guide them to the best implementation strategies for protecting or restoring their own lake.

Moriya has 14 years' experience working with lake associations, conducting lake monitoring programs and assessing lake water quality data. To date, Moriya and RMB staff have completed 451 lake reports for 15 county water plans and numerous lake summaries for lake associations. In addition, Moriya and RMB staff train over 500 volunteers annually (2007-present) through the RMB Lakes Program.

Also presenting will be Ben Underhill of East Otter Tail Soil and Water Conservation District (EOT SWCD) who will provide information about the Otter Tail River Watershed.




Call 911. Then What? OTC COLA Meeting May 17, 2018

Aquatic Invasive Species Research Center Update

The Minnesota Aquatic Invasive Species Research Center (MAISRC) held an Update at the M-State Campus in Detroit Lakes MN, on June 8, 2018. Over 120 Minnesota lake property owners and concerned citizens attended the event. Featured speakers included Dr. Nicholas Phelps, Director of MAISRC, Jake Ferguson, Postdoctoral Associate MAISRC, Megan Weber, Extension Educator, Dr. Ranjan Muthukrishnan, Postdoctoral Research Associate and Bethany Bethke, Fisheries Research Biologist.

The Update focused on the progressive and continued research being conducted by MAISRC to combat the encroachment of Aquatic Invasive Species (AIS) into Minnesota lakes. Of special interest was the proliferation of zebra mussels and the looming threat of starry stonewort infestation into new lakes.

OTC COLA was proud to co-sponsor the event with the Otter Tail County Aquatic Invasive Species Task Force, Pelican River Watershed District, Becker County Coalition of Lake Associations, Hubbard County Coalition of Lake Associations and Becker Soil and Water Conservation District.
