




Our Lakeshore/Groundwater Connection Videos

WRAPS Update

In 2016 the Minnesota Pollution Control Agency (MPCA) and other state agencies started monitoring the Otter Tail River Watershed for water quality and aquatic life. Monitoring was completed in 2018 and review of the all the information started shortly after. Based on some of the review, assessed waters were classified as impaired or meeting state standards. Finally, in 2020, we are nearing the end of that process. All the reports and data have been reviewed,

the suspected causes have been identified, and final reports have been developed. These final reports are called the Total Maximum Daily Load (TMDL) and Watershed Restoration and Protection Strategies (WRAPS).

Free Nitrate Water-Testing Clinics In Otter Tail County

Homeowners who rely on private wells for their drinking water supply should test for nitrates on a regular basis. Private well owners are encouraged to participate at a free nitrate testing clinic that will be held from 10:00 a.m. to 3:00 p.m. at the West Otter Tail SWCD office in Fergus Falls on July 21St, 2020 or 10:00 a.m. to 3:00 p.m. at the Ottertail Community Center in Ottertail on July 24th, 2020. This year's nitrate testing clinics will be run slightly different because of the Coronavirus. We will be following Department of Health and CDC guidelines to reduce the risk of spreading the virus. Participants must stay in their car for the duration of the test; staff will retrieve your sample, test it, and return to you with results. Look for designated parking spots at water testing locations.

REMINDER- Dock And Riparian Use Ordinance

Pursuant to the Use Ordinance the public is reminded to comply with the Otter Tail County Dock and Riparian Use Ordinance, a dock, pier, wharf, or boatlift must be registered with the Otter Tail County Land & Resource Management Office before being moved from one body of water to another. Registration is free and easy. Call Otter Tail County at: 218-998-8113
