# Otter Tail County Reports Good Strides In Fight Against Invasive Species

The Otter Tail County Aquatic Invasive Species (AIS) program, in its ninth year in 2021, continued to take a proactive approach to stop the spread of invasives throughout the county.

Among the achievements, in a prepared statement by county AIS Specialist Spencer McGrew for county board members on Mach 15, were 22 watercraft inspectors logging 9,465 watercraft inspection hours at 97 county public water accesses totaling 12,660 inspections.

# Tour July 11

Starry stonewort is a noxious, matting algae posing a clear and present danger to lake property values and the quality of lake experience across Minnesota. The alarming outbreak of starry stonewort on Lake Koronis, near Paynesville, MN is creating high awareness of the threat and prompting aggressive action to stop its spread.



Otter Tail Coalition of Lake Associations (OTC COLA) and the Otter Tail County AIS Task Force is sponsoring a bus tour from Fergus Falls, MN to Lake Koronis on July 11, 2022. The tour will include a two-hour travel to and from Lake Koronis and approximately two hours visiting two sites of starry stonewort infestations. Kevin Farnam, Starry Stonewort Control Advocate and James Wooton, MAISRC Starry Trek Detector will provide valuable information and answer questions on the bus and at selected sites on Lake Koronis.

# DNR Reminds Anglers To Follow Northern Pike Zone Regulations

The Minnesota Department of Natural Resources reminds anglers who might want to keep northern pike to familiarize themselves with the regulations and be prepared to measure the fish. Minnesota has three northern pike zones that apply to inland waters and reflect the differing characteristics of pike populations across the state:

- North-central: Limit of 10 northern pike; anglers must release all fish 22 to 26 inches, with only two fish longer than 26 inches allowed in possession.
- Northeast: Limit of two northern pike; anglers must release all fish 30 to 40 inches, with only one fish over 40 inches allowed in possession.
- South: Limit of two northern pike; minimum size 24 inches.

Throughout the state, special regulations that cover individual lakes, rivers and streams remain in effect and take precedence over the zone regulations. The northern pike zone regulations do not apply to border waters. # Take The Pledge To Prevent Aquatic Invasive Species Spread

Heading into the summer recreation season, the Minnesota Department of Natural Resources is rolling out a new online pledge to help prevent the spread of aquatic invasive species.

Anyone 18 or older can go to the <u>new Pledge to Protect Minnesota Waters page of the DNR website</u> (mndnr.gov/AISPledge) to take the pledge and upload a photo, if desired. The pledge affirms that participants will follow Minnesota's "Clean, Drain, Dispose" laws and will encourage others to do so.

# Volunteers Needed In Otter Tail And Becker Counties For DNR Loon Survey

The Minnesota Department of Natural Resources is seeking volunteers to help monitor the loon population in Otter Tail and Becker counties. Volunteers can choose one (or more) lakes to count the number of adult and juvenile loons seen and report these observations to the MNDNR for data analysis. The survey will take place from July 1 through July 11, 2022. Volunteers need to monitor their lake(s) for one day during this survey period.

For the past 28 years, with the assistance of hundreds of volunteer observers, the MNDNR has gathered information about common loon numbers on more than 600 lakes distributed among six regions, or "index areas," throughout the state.

# DNR Cautions Lakeshore Property Owners About Improper Use Of Hydraulic Jets

The Minnesota Department of Natural Resources frequently receives questions about devices that generate water current to blast muck and plants away. They have various trade names, but the DNR refers to these devices generically as hydraulic jets. Even though you can buy one in Minnesota, they cannot be used in any way that disturbs the bottom of the lake or uproots plants.

A person may legally operate a hydraulic jet if it is placed high enough off the lake bed so that it does not disturb the bottom or destroy rooted aquatic plants. It should be directed upward toward the water's surface, which can prevent dead vegetation and duckweed from collecting around docks and boat lifts.

Aquatic plants are important to lakes. They help maintain water clarity, prevent erosion, stabilize the bottom and provide habitat for fish and wildlife and are therefore protected under state law.

Specific regulations govern what situations require permits for aquatic plant removal. Regulations and a guide to aquatic plants can be found on the <u>DNR</u> <u>website</u> (mndnr.gov/ShorelandMgmt/Apg/Regulations.html). To apply for a permit, visit the DNR's <u>permitting and reporting system</u> (mndnr.gov/MPARS).

## Handling Big Fish Is Subject Of Video

A new video by the Minnesota Department of Natural Resources aims to educate anglers about how to properly handle large fish during catch-and-release.

Being properly equipped and understanding how to handle a large fish is critical to ensuring the fish's survival after release. The video covers the proper equipment for large fish, minimizing the time the fish is out of the water, protecting the fish's slime coating, holding the large fish horizontally and supporting the fish's body, and how to release the fish.

The flathead catfish fishing season begins Friday, April 1. Additionally, seasons are around the corner for other large fish like lake sturgeon, muskellunge, northern pike, steelhead and others.
